## What About Accessibility Toolbars (aka Overlays)?

Toolbars use AI (Artificial Intelligence) which can **only address 30% of accessibility issues**.

U.S. companies implementing web accessibility can get up to \$5,000 tax credits per Title 26. Internal Revenue Code. Section 44

### **Online Traffic and Engagement Increases**

WEBSITE CONTENT ACCESSIBILITY GUIDELINES 2.1 (WCAG 2.1)

### **Web Accessibility Lawsuits**



From 2016 to 2020, the number of lawsuits related to digital accessibility increased by more than 1,100%.

- Each lawsuit at a minimum will cost the company \$25,000
- National Federation of the Blind vs. Target: Target paid \$6M damages
- Davis vs. Bag'n Baggage: Bag'n Baggage paid over \$100,000 in legal fees
- National Association of the Deaf v. Netflix: Netflix paid \$40,000 execution fund \$755,000 legal fees
- Gil v. Winn-Dixie: Winn-Dixie paid \$105,000 in legal fees
